PARTICIPATION TERMS

(must be signed by the student and natural parents)

- 1. While in Canada, I am always under the jurisdiction of the national, provincial, and local laws. I will obey all laws and refrain from illegal activity (e.g. shoplifting, stealing, harming others, using technology inappropriately, etc.).
- 2. I will not possess, purchase, or consume alcohol, cannabis, cigarettes or e-cigarettes, tobacco, or use illegal drugs while enrolled in the New Brunswick International Student Program (NBISP).
- 3. I will obey the rules of my host family and will make every effort to adjust to, and become a member of, the host family and community. This includes any curfews, chores, and other rules they have established.
- 4. I will obey the rules of the school I attend. These rules include, but are not limited to, attendance, actively participating in classroom work, and adhering to the standards for personal technology use.
- 5. I will make every effort to speak English.
- 6. I will not drive motorized vehicles except within the context of a formal driver's training program. Driver's training may be taken only with written permission of my natural parents and I will allow NBISP to hold my driver's license until I return to my home country.
- Travel within the Maritimes and Quebec (PEI, NS, NB, and Quebec) I understand with the acknowledgement
 of my host family and consent of my custodian while in Canada, I can travel throughout the Maritimes and
 Quebec with them, a student group, or other family.
- 8. Travel outside the Maritimes and Quebec (NS, NB, PEI, and Quebec) I understand that I require approval from the NBISP to travel outside the Maritimes and Quebec. Travel outside the Maritimes and Quebec must be chaperoned by a responsible adult (minimum age 25 years) and requires written approval, in English, from my family. I will also advise the NBISP at least two weeks prior to my departure of my plans to travel.
- 9. I understand my program fees cover my monthly charges for homestay, medical, and tuition. Some schools charge all their students an additional fee for such items as lockers, lab fees and school agendas. I understand I am responsible for paying these fees on my own. If I choose to participate in school sports or other extracurricular activities the school may charge a fee and it is my responsibility to pay these fees. I understand that transportation to/from the airport for additional travel (ex. holiday travel home) that I choose to make are at my expense and I will be charged a fee for this transportation. Furthermore, there are some expenses that are not covered by the student medical insurance and I understand that these expenses will be the responsibility of the student and their natural parents (for more information on what is and is not covered by the NBISP medical coverage, please consult the following website: https://nbispinsurance.ca/insurance-policies/your-group-coverage).
- 10. I understand visits by my family or friends from my home country are permitted no sooner than six weeks after my arrival in New Brunswick. If my family or friends visit, they are responsible for arranging their lodging outside the home of my host family.
- 11. I recognize I will make a full academic effort and, as a student in the NBISP, any report about my participation (marks, behaviour, etc.) can be sent to my parents and/or agent (if applicable). Furthermore, I understand that I am expected to maintain a passing average of 60% while enrolled in the NBISP. If I fail to meet this academic





standard in two consecutive reporting periods, I understand that my participation in the program will be under review.

- 12. I confirm information provided in this application is complete and factual, including any medical or dietary conditions relevant to my participation in NBISP.
- 13. I consent to the use of my personal information for: (a) applying to the NBISP, (b) processing of my application, and (c) if I am accepted into the NBISP, use of my information by the school district and school where I will attend classes, as well as my host family.
- 14. I understand while enrolled in the program a custodian from the NBISP will be assigned to me. The custodian can make decisions (e.g. medical) on my behalf. The custodian will always use fair and reasonable judgment.
- 15. I understand personally identifying information about me including, but not limited to, name, grade, school, video/voice/audio recordings, images (photos), and my work may be used in print publications, online, and in social media (including but not limited to Twitter, Facebook, YouTube, and Instagram) for promotional purposes by the NBISP and my respective school district and school.
- 16. I give permission to participate in newspaper/print publications, radio, and television media interviews. This permission may extend beyond my participation in the NBISP and may be withdrawn by me, or my parent, with written notice.
- 17. I understand I should limit communication with my natural family and friends in my home country. This will help to ensure that I enjoy a full cultural experience and stay engaged with the program. Upon arrival in the NBISP, I can contact my family and then it is recommended communication be limited to once per week.

PROGRAM TERMINATION: The NBISP reserves the right to terminate participation for the violation of program participation terms and/or when a participant's mental and/or physical health, as determined solely by the NBISP, is in jeopardy. Students who are expelled from the NBISP will not be given a refund or a transcript. If a student's education or homestay needs are greater than disclosed in the application process, or change during the student's stay in the NBISP, the NBISP has the right to terminate participation in the program and send the student home at their own expense.

I, ______, understand I am expected to follow and obey all the terms stated. I also understand if I do not, I may be sent back to my home country immediately at my own expense. I understand all matters relating to this contract will fall under the legal jurisdiction of the Province of New Brunswick.

PARENTS' NOTE: In New Brunswick, there is no specific age for giving consent for health care decisions. It is recommended students discuss their medical care conditions with their natural parents; however, if they can understand the benefits and possible reactions, to their medical care, parental consent may not be required for mature minors. Consent cannot be overturned by their parent or legal guardian. If the student is assessed as being unable to give informed consent, then their parent/legal guardian could be involved. Students enrolled in the NBISP are legally entitled to privacy in matters related to personal medical care or prescription drugs in the Province of New Brunswick.

By signing this application, I declare the information provided herein is complete and correct to the best of my knowledge. I am responsible for the accuracy of the information provided and any inaccuracies may result in program termination.
