

PARTICIPATION TERMS

Must be signed by student and natural parents.

- 1. While in Canada I am always under the jurisdiction of the national, provincial, and local laws. I will obey all laws and refrain from illegal activity (shoplifting, stealing, harming others, using technology inappropriately etc.). I acknowledge it is my responsibility to be generally familiar with the laws which might affect me while I am in Canada. And, I acknowledge if I am in doubt about the legality of any activity in which I am engaging, or planning to engage, it is my responsibility to ensure I am complying, and will be complying, with all applicable laws.
- 2. I will not possess or purchase or consume alcohol, cannabis, products which contain cannabis or cannabis by products (such as gummies, chewables, edibles, oils, or creams), or use illegal drugs while enrolled in the Nova Scotia International Student Program (NSISP).
- 3. I will make every effort to always speak English.
- 4. I understand my program fees cover my monthly charges for room, board, medical, and tuition. Some schools charge all their students an additional fee for such items as lockers, school agendas, participating in sports teams, certain extra-curricular activities (such as skiing), etc. It is my responsibility to pay these fees.
- 5. I understand I must have my own personal spending money while studying in Nova Scotia. It is my responsibility to cover the costs of my entertainment, personal spending, toiletries, and anything outside the scope of the program costs, including such things as sports and other extra-curricular activities.
- 6. I am responsible for booking my arrival and departure tickets, including trip interruption insurance, within the dates of the program. I am also responsible for any issues with my luggage, missed connections, and any other travel arrangements.
- 7. I will not drive motorized vehicles except within the context of a formal driver's training program or offered by, or in conjunction with, my school. Driver's training may be taken only with the written permission of my parents and I will allow the NSISP to hold my driver's license until I return to my home country.
- 8. **Travel within the Maritimes (Nova Scotia, New Brunswick, Prince Edward Island)**—I understand, with the acknowledgement of my host family and consent of my custodian while in Canada, I can travel throughout the Maritimes with them, a student group, or other family. Personal travel arrangements are my responsibility and my expense, and at my own risk.
- 9. **Travel outside of the Maritimes (NS, NB, PEI)**—I understand I require approval from the NSISP to travel outside the Maritimes. Travel outside the Maritimes must be chaperoned by a responsible adult (minimum age of 25, or at the discretion of the RCE/CSAP) and requires written approval, in English, from my family. I will submit the request to travel form to my custodian/designate at least two weeks prior to my departure of my plans to travel. Personal travel arrangements are my responsibility and my expense, and at my own risk.
- 10. I understand visits by my family or friends from my home country are permitted no sooner than six weeks after my arrival in Nova Scotia. If my family or friends visit, they are responsible to make their own lodging and travel arrangements outside the home of my host family.
- 11. I will obey the rules of my home stay and will make every effort to adjust to, and become a member of, the host family and community. This includes any curfews, chores, and other rules they have established.
- 12. I will obey the rules of the school I attend. These rules include, but are not limited to, attendance, actively participating in classroom work, and adhering to the standards for personal technology use as outlined in the NSISP student handbook. I agree to take part in extra-curricular activities, acknowledging that some extra-curricular activities (such as skiing, hiking, and snowshoeing) can be inherently dangerous and I undertake those activities at my own risk.

- 13. I recognize I will make a full academic effort, including being enrolled in a full course load, and any report about my participation (marks, behaviour etc.) can be sent to my parents and/or agent (if applicable).
- 14. I consent to the use of my personal information for: (a) applying to the NSISP, (b) processing of my application, and (c) if I am accepted into the NSISP, use of my information by the Nova Scotia regional centre for education/ Conseil scolaire acadien provincial and school where I will attend classes, as well as my host family.
- 15. I understand and agree while I am enrolled in the NSISP, a personal custodian will be assigned to me, and will generally be responsible for me. I further understand and agree the custodian can make decisions (including decisions regarding any medical treatments I may require or may seek) on my behalf, understanding that wherever practicable, the custodian will seek my input and the input of my parents/legal guardians prior to making any such decisions on my behalf.
- 16. I understand personal identifying information about me including, but not limited to, name, grade, school, video/voice/audio recording, images (photos), and my work may be used in print publications, online, television, radio, and in social media for promotional purposes by the Nova Scotia International Student Program and my respective regional centre for education/Conseil scolaire acadien provincial. This permission may extend beyond my participation in the program and may be withdrawn by me, or my parent/legal guardian, with written notice.
- 17. I understand I should limit communication with my natural family and friends in my home country. This will help to ensure I enjoy a full cultural experience and stay engaged with the group. Upon arrival in the NSISP, I can contact my family and then it is recommended communication is limited to once a week.
- 18. I understand once I am enrolled as an NSISP student, I remain in the NSISP for the duration of my studies in secondary school. I cannot return to the Program and live on my own or with a friend.
- 19. I confirm information provided in this application is complete and factual, including any academic, medical or dietary conditions relevant to my participation in the NSISP. I am responsible to update my agency if anything changes in my application after submission and prior to arrival. Failure to do so may result in dismissal from the program.
- 20. My family and I agree to treat the program staff, host family, schools, and community members with respect and understand verbal and physical abuse will not be tolerated and may result in dismissal from the program.
- 21. I have read the Student Handbook and understand the content of the document.

Program Termination: The NSISP reserves the right to terminate participation for the violation of program participation
terms and/or when a participant's mental and/or physical health, as determined solely by the NSISP, is in jeopardy.
Students who are expelled from the NSISP will not be given a refund or transcript. If a student's education or homesta
needs are greater than disclosed in the application process, or change during the student's stay in the program, the
NSISP has the right to terminate participation in the program and send the student home at their own expense.

I understand all matters relating to this contract will fall under the legal jurisdiction of the Province of Nova Scotia.

Parent's note: In Nova Scotia, there is no specific age for giving consent for health care decisions. It is recommended students discuss their medical care conditions with their natural parents; however, if they can understand the benefits, and possible reactions, to their medical care, parental consent may not be required for mature minors. Consent cannot be overturned by their parent or legal guardian. If the student is assessed as being unable to give informed consent, then their parent/legal guardian could be involved. Students enrolled in the NSISP are legally entitled to privacy in matters related to personal medical care or prescription drugs in the Province of Nova Scotia.

Custodianship of International Students Enrolled in the NSISP

Students enrolled in the NSISP must be cared for by a custodian. The NSISP assigns the custodian. Custodianship requires that a legal arrangement be made to give the custodian in Canada the permission to act in place of a parent or legal guardian. A Custodianship Declaration must be signed by the custodian and the parents or guardians and the signatures must be certified by a notary public or Commissioner of Oaths.

Custodians must be:

- a staff member of the NSISP or of the participating regional centres for education or Conseil scolaire acadein provincial
- a Canadian citizen or a permanent resident of Canada;
- over 19 years old;
- live within a reasonable distance of the student's intended residence and school; and
- be able to fulfil his/her obligations as a custodian as outlined below

Role of the Custodian

The primary role of the custodian is to ensure students are safe and have the necessary advice and support to reside safely while enrolled in school in Canada. NSISP requires all students enrolled in the program have a custodian.

Establishing a custodial relationship

To establish a custodial relationship a Custodian Declaration must be duly completed, signed and notarized. Part 1 will be signed by the Custodian in Canada and Part 2 will be signed and notarized by the parents or guardians in their home country. The fully signed and notarized custodianship agreement will be required by Immigration, Refugees and Citizenship Canada for a study permit application. A Canadian Visa Officer must be satisfied that adequate arrangements have been made for the care and support for an unaccompanied minor before issuing a study permit.

The custodian is a member of a larger staff. The staff of the NSISP, the participating regional centres for education, the Conseil scolaire acadien provinical, and the school staff all work together to ensure the student is properly advised and cared for. Host families, community partnerships, and other members of our extended support team also assist students in having a safe and successful program.

Obligations of the Custodian

- Undertake custodianship for student taking the best interest of the child into consideration while he/she is studying in Canada enrolled with NSISP;
- Assist in registering students in schools where they will be registered in classes and advise on access to other supports available at the school level (personal and academic counselling, support for academics, etc);
- Appoint a Homestay Coordinator to the student whose role is to support the student in adjusting to their new environment;
- Appoint a host family whose role is to provide a suitable home and adequate meals to the student;
- Be connected with outside agencies to offer guidance and provide referrals (*e.g.* libraries, medical services, passport/visa/study permit renewals);
- Make the necessary arrangements for the care, supervision and support of the student as appropriate;
- Be the official contact for communication with the parents or guardians of the student through the authorized agent;

- Communicate with host families, Homestay Coordinators and school staff, as required, to monitor students' well-being and academic progress;
- Provide consent as needed by the school for academic program and/or activities;
- Find proper medical care, if required;
- Monitor the student and advise the authorized agent of academic, behavioral or serious medical issues;
- Coordinate transfer of custodial duties, if required;
- Respond to emergency situations involving the student;
- Make decisions in case of an emergency including but not limited to medical (injury, critical illness),
 legal, immigration and school related;
- Communicate with the parents, through the authorized agent, as soon as reasonably possible in case of emergency;

The student acknowledges and agrees that no Custodian will be liable for any decision, as referred to herein, or otherwise, or for the effects of any such decision as may result to or accrue to the student, so long as such decision was made by the Custodian in good faith, on the basis of the best information and advice available to the Custodian at the time of any such decision, and the Custodian has made her or his best efforts, commensurate with the circumstances, to communicate with the student's parents of legal guardians in advance of any such decision.

Duration of custodianship

Custodianship will only be in place while the student is physically present in Canada and only for the duration of the school year (September-June). Custodianship will cease and is revoked upon the completion of the program. Custodianship will also be revoked for any student who has been dismissed from the NSISP. Should the student decide to remain in Canada after their program has concluded and over the summer holidays, parents are fully responsible for making alternative arrangements for the care, custody, and insurance of their child. The NSISP reserves the right to change the custodian to an alternative NSISP staff member at any time prior to, or after the student's arrival to Canada.

- f. A sickness or injury that, at the time of departure from the Home Country, might reasonably be expected to require medical treatment, surgery, or hospitalization.
- g. Medication commonly available without a prescription; fertility drugs, contraceptives, vitamin preparations, acne medications, baldness remedies, nicotine resin products, dietary supplements, growth hormones or weight loss products.
- h. Translation services of any kind, even when utilized in the delivery of medical services.
- i. Organ Transplants.
- j. Any sickness, injury or medical condition resulting from the commission or attempted commission of an illegal act.
- k. Expenses related to any pre-existing condition that is not stable, as determined by Medavie Blue Cross.

To assess my application for benefits, I authorize any physician, practitioner, hospital or medical facility, insurance company, or any other organization, institution, or person, who have information required to analyze my application, to convey that information to my insurer or its representative. During your son/daughter's participation in the Nova Scotia International Student Program (NSISP) he/she may take part in various activities either through their school, their host family, and/or their friends. These activities will be mainly cultural. However, some may be for entertainment. Your son/daughter will be transported to activities by bus, passenger van, host family vehicle, or public transportation. Activities organized by the NSISP or Regional Centre for Education (RCE) or Conseil scolaire acadien provincial (CSAP) will follow the chaperone ratio set by their respective RCE/CSAP (1 adult to 10–15 students). Please note your child may not participate in all activities listed. The activities listed below are only examples of some activities available in Nova Scotia.

Additionally, your child will not always be participating in an activity with the school or program staff. Students have free time and will participate in activities organized by their friends and with their friends and not school or program staff. Their friends and the families of their friends will transport and organize activities that are not recognized by our program. These activities are outside of the direction of the program and are not subject to the regular guidelines set by the NSISP and RCE/CSAP.

<u>Please read carefully.</u> This form must be signed and returned with the application for the Nova Scotia International Student Program or your child will <u>not be allowed</u> to participate in the following activity(ies). IN CONSIDERATION of the NSISP providing my child,, an opportunity to participate in the activity described below during their enrollment period in the NSISP, I hereby give and provide my consent, and acknowledge by my signature my child may participate.
1. Activity Description
During my son/daughter's participation in the NSISP I give permission for them to participate in various downhill skiing activities which may include, but are not limited to, school ski trips, ski clubs, ski trips with friends and host families.
2. Risk of Accident
Alpine Sports are physically demanding and involve inherent risks which are beyond the control of the School, the RCE/CSAP, the NSISP and the Supervising Personnel. Falls, collisions, and other incidents may occur and cause injury. The safety and well-being of students is a prime concern and attempts are made to manage the foreseeable risks inherent in such physical activities. However, in permitting your child to partake in the activity, you and your child assume the inherent risks of the sport.
Students are encouraged to take ski lessons and wear proper equipment including the mandatory use of a helmet to mitigate their risk of injury. Students must follow all the rules of the ski hills and must observe their level of experience when selecting which trails to ski.
3. <u>Supervision</u>
School and ski clubs are supervised by school staff and chaperones but there is no guarantee that trips outside of schools will be supervised by adults. We encourage parents to discuss supervision for non–school organized trips with their children.
4. <u>Health and Medical Treatment</u>
My child does not have any illness, allergy, or disability that prevents his or her participation in this event

5. Equipment and Clothing
